

EULA for SPOT Subscription Software

Introduction

This End User License Agreement (the "Agreement") is a binding agreement between you ("you" or "User" or "Licensee") and Diagnostic Instruments, Inc., d/b/a SPOT Imaging ("Company" or "SPOT"). This Agreement governs your use of SPOT software applications for the Windows operating system that require a subscription. The software ("Software" or "Application") shall mean any software (whether provided as downloadable or on physical media), tool, utility, documentation, or similar delivered by SPOT including the license file, and any revision, update, or upgrade hereto which are made available by SPOT to the End User.

The terms and conditions contained in the Agreement

Company reserves the right to change or modify any of the terms and conditions contained in the Agreement without notice and all such revisions are effective immediately upon posting and apply to all access to and continued use of the Application.

By installing the application, you agree to be bound and comply with this agreement.

License

SCOPE OF THE END USER LICENSE

- 1.1. SPOT hereby grants to the Licensee a non-assignable, non-transferable, nonsublicensable and non-exclusive right to use the Software in accordance with the terms and conditions set out in this EULA solely for the Licensee's own internal business operations. The license is effective upon installation by the Licensee and remains in force until termination by either party.
- 1.2. The Software is licensed as (i) a subscription license that needs to be annually (every 12 months) renewed, or (ii) a "perpetual" license that is only available in certain geographic regions
 - 1 A subscription license gives the Licensee a right to use the Software (the current or at any time the latest version) one (1) year from the date of purchase. If the subscription license is not renewed, the Licensee no longer has any right to use the Software.
 - 2 A "perpetual" license gives the Licensee a right to use the licensed version of the Software until January 1, 2050.
- **1.3.** The Software is a standard product. It shall be the sole responsibility of the Licensee to ensure that the functions of the Software fulfill the requirements and expectations of the Licensee.



The Licensee's right to use the Software requires that the Licensee has accepted the terms and conditions in this EULA.

Subject to the terms of this Agreement, Company grants you a limited, non-exclusive, revocable, non-transferable license to download, install, and use the Application for your use on a single computer owned or otherwise controlled by you ("Computer") strictly in accordance with the Application's documentation.

You shall not:

- (a) copy the Application, except as expressly permitted by this Agreement;
- (b) modify, translate, adapt or otherwise create derivative works or improvements, whether or not patentable, of the Application;
- (c) reverse engineer, disassemble, integrate, modify, remove, decompile, decode, create derivates works or updates of, adapt, or otherwise attempt to derive or gain access to the source code of the Application or any part thereof;
- (d) remove, delete, alter or obscure any trademarks or any copyright, trademark, patent or other intellectual property or proprietary rights notices from the Application, including any copy thereof;
- (e) rent, lease, lend, sell, sublicense, assign, distribute, publish, transfer or otherwise make available the Application or any features or functionality of the Application, to any third party for any reason, including by making the Application available on a network where it is capable of being accessed by more than one device at any time; or
- (f) remove, disable, circumvent or otherwise create or implement any workaround to any copy protection, rights management or security features in or protecting the Application.

You acknowledge and agree that the Application is provided under license, and not sold, to you. You do not acquire any ownership interest in the Application under this Agreement, or any other rights thereto other than to use the Application in accordance with the license granted, and subject to all terms, conditions and restrictions, under this Agreement. Company and its licensors and service providers reserve and shall retain their entire right, title and interest in and to the Application, including all copyrights, trademarks and other intellectual property rights therein or relating thereto, except as expressly granted to you in this Agreement.

Updates

Company may from time to time in its sole discretion develop and provide Application updates, which may include upgrades, bug fixes, patches and other error corrections and/or new features (collectively, including related documentation, "Updates"). Updates may also modify or delete in their entirety certain features and functionality.

You agree that all Updates will be deemed part of the Application and be subject to all terms and conditions of this Agreement.



Term and Termination

Company may terminate this Agreement at any time without notice if it ceases to support the Application, which Company may do in its sole discretion. In addition, this Agreement will terminate immediately and automatically without any notice if you violate any of the terms and conditions of this Agreement. Termination will not limit any of Company's rights or remedies at law or in equity

Furthermore, you agree that Company assumes no responsibility for the content you submit or make available through this Application.

Export Regulation

The Application may be subject to United States export control laws, including the US Export Administration Act and its associated regulations. You shall not, directly or indirectly, export, re-export or release the Application to, or make the Application accessible from, any jurisdiction or country to which export, re-export or release is prohibited by law, rule or regulation. Any action or proceeding arising out of or relating to this Application and/or under this Agreement will be instituted in the State of Michigan in the Country of the United States, and each party irrevocably submits to the exclusive jurisdiction of such courts in any such action or proceeding. You waive any and all objections to the exercise of jurisdiction over you by such courts and to the venue of such courts.

Entire Agreement

This Agreement constitutes the entire and only agreement between the parties in relation to its subject matter and replaces and extinguishes all prior or simultaneous agreements, undertakings, arrangements, understandings or statements of any nature made by the parties or any of them whether oral or written (and, if written, whether or not in draft form) with respect to such subject matter. Each of the parties acknowledge that they are not relying on any statements, warranties or representations given or made by any of them in relation to the subject matter of this Agreement, save those expressly set out in this Agreement, and that they shall have no rights or remedies with respect to such subject matter otherwise than under this Agreement save to the extent that they arise out of the fraud or fraudulent misrepresentation of another party. No variation of this Agreement shall be effective unless it is in writing and signed by or on behalf of Company.



Waiver

No failure to exercise, and no delay in exercising, on the part of either party, any right or any power hereunder shall operate as a waiver thereof, nor shall any single or partial exercise of any right or power hereunder preclude further exercise of that or any other right hereunder.
